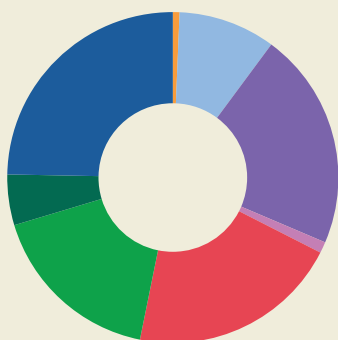

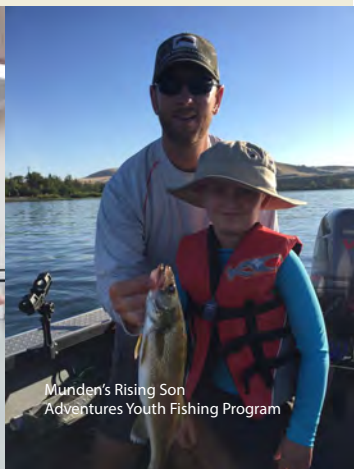
In 2017, 3RCF distributed \$321,559 to support nonprofits and scholarships. Eighty percent (80%) of these distributions were determined by donors.

Community foundations are grant making charities dedicated to improving the lives of people in a defined local geographic area. They bring together the financial resources of individuals, families, and businesses to support nonprofits in their communities.

Specifically, a community foundation is a collection of separate endowed funds donated by community-minded donors, each reflecting the various ways they choose to support the causes that matter to them.

Recognized for its flexibility, permanence, and trustworthiness, a community foundation has two primary purposes:

1. To stimulate the creation of funds to support nonprofits in the community now, and in the future;
2. To address community needs and opportunities through grant making and organizational leadership.

The endowed funds at Three Rivers Community Foundation are established by donors with diverse interests, and the amount to establish a fund is flexible.
