



HOW TO GIVE IRA Rollover or Qualified Charitable Distribution

If you have met the age threshold, you can transfer up to \$100,000 directly from your individual retirement account (IRA) to 3 Rivers Community Foundation tax-free. This give may count toward your required annual minimum distribution. Many people have found this to be an easy, tax-smart way to support the community they love. 3 Rivers Community Foundation will work with you to see this gift support causes you care about.

HOW IT WORKS

- You work with your IRA administrator to confirm your eligibility and to transfer up to \$100,000 from your IRA directly to 3RCF.
- If married, each spouse can transfer up to \$100,000 from their IRA.
- You notify 3RCF of the gift. Together we'll make a plan to pass the gift on to other charities, or to start or grow an endowed fund to support the causes of your choice.
- Your gift will support the charities or causes you care about and this simple process provides you with one tax receipt, from 3RCF.

CHOOSING CHARITY OVER TAX

Qualified Charitable Distributions from your IRA are a flexible tool to meet a variety of charitable needs, at your direction. Your gift - and all future earnings from your gift - become a permanent source of community capital, helping to do good work forever.
