

Call for Applications Richland Fire & Emergency Services Scholarship

These men and women have a significant impact on our community and deserve recognition for their integrity and unwavering dedication to duty.

The criteria for application include the following:

- The applicant must be a RF&ES firefighter in good standing with the department
- The applicant must be enrolling, or enrolled, in a degree program (undergraduate through post-graduate) at an accredited college or university, full or part-time.
- The applicant must have completed the department's probationary period.
- This scholarship is not available to members or relatives of the RF&ES Scholarship Selection Committee or employees or families of the 3 Rivers Community Foundation.

References: Please include two reference letters with your application. These letters should come from individuals who know you thorough your academic, work, or community involvement. Please do not submit references from family members.

Letter of Good Standing from Supervisor (Attached)

Deadline: The completed application, along with reference letters must be postmarked by March 31, 2026. Any materials postmarked after this date will not be considered. Send fully completed application to:

Decision notification letters will be sent in May. **Three \$2,000 scholarships will be awarded.** The scholarship funds will be disbursed directly to the institution in the recipient's name, upon receipt of enrollment verification.
